CONSTITUTION OF COMMISSION

1. Toghfar ochtar baill, mar leanas:- Laighean, Mumhan, Uladh (Co. Lu san áireamh): beirt ball ón cúige, Connacht agus an Bhreatain: ball amháin an Limistéar.
2. Ní bheidh cead ach ag daoine a bhéas cláraithe mar Moltóir nó Múinteoir (T.C.R.G.) bheith ina h-iarrathóirí nó vótaí a chaitheamh, and Féadfaidh leo bheith ina h-iarrathóirí ach dá gceantar toghacháin féin amháin agus ní bheidh cead acu iarrthóir d'ainmniú taobh amuigh den cheantar sin.
3. Déanfar an vótáil trí ballóid rúnta phoist.
4. Is de réir na h-ionadaíochta cionúire agus ar modh an aonghutha inaistrithe a bheidh an toghacháin.
5. Cathal Uasal Ó Feinneadha a bhéas ina Oifigeach Comháireamh agus ní bheidh dul thar a bhreith maidir le ceist ar bith ag baint leis an dtoghchán. Beidh cead aige daoine ar bith ar mhian leis a roghnú mar cuntóirí.
6. Féadfaidh le h-iarrthóir a bheith ainmnithe ag moltóir nó múinteoir cláraithe ar bith dá cheantar féin.
7. Déanfar na ballóidí d'oscailt a scrúdú agus a comháireamh go poiblí. Fógrófar ionad, am agus cása agus chomháireamh nuair a bhéas na páipeirí bhótála dá cur amach.
8. Nuair a bhéas iarrthóirí á ainmniú ní mór a cuimhniú gur trí Gaeilge amháin a mbíonn cruinnithe an Choimisiún.
1. Eight members shall be elected as follows:- Leinster, Mumster, Ulster (Including Co. Louth): 2 members each, Connacht and Britian one member each.
2. Only persons currently registered as Adjudicators or Teachers (T.C.R.G) may vote or stand for election. They may stand for election only in, and propose for election only persons in their own electoral area.
3. Voting shall be by secret postal ballot.
4. The members shall be elected on the system of proportional representation by means of the singal transferable vote (i.e. the "R.P." system).
5. The Returing Officer shall be Cathal Ó Feinneadha President of Conradh na Gaeilge, whose decision in all matters pertaining to the election shall be final. He may appoint at his discretion such persons as he may think fit to assist him in his duties.
6. A Candidate may be moninated by any other registered adjudicator or Teacher (T.C.R.G.) of his own electoral area (the attached form should be used).
7. The ballots will be opened, checked and counted in public and any Teacher or adjudicator may attend. The date, time and venue of the count will be announced when ballot papers are being issued.

7. Déanfar na ballóidí d'oscailt a scrúdú agus a comháireamh go poiblí. Fógrófar ionad, am agus áta agus chomháireamh nuair a bhéas na páipeirí bhótála dá cur amach.

8. Nuair a bhéas iarrthóirí á ainmniú ní mór a cuimhniú gur tré Gaeilge amháin a mbíonn cruinnithe an Choimisiún.

9. Ní mór ainmniúcháin bheith i lámhaibh Rúnaí an Coimisiún ar 15 Bealtaine, 1967 ar a dhéanaí. Seoltar iad go dtí:
