AN COIMISIUN LE RINCI GAEЛАCHA

The Irish Dancing Commission has for some time been concerned about the effects the dispute in dancing circles is having on Irish dancing throughout the country. We have also been made aware of much goodwill on all sides for a settlement of the dispute. Through the intervention of mediators it was possible for individuals from both sides to meet and discuss ways and means of arriving at a settlement.

Suggestions arising out of these meetings were discussed at length by An Coimisiun at a meeting on February 27th 1971 and it was felt that the following arrangements might be acceptable to all teachers.

An Coimisiun is prepared to grant registration to all teachers and adjudicators in the appropriate category provided:

- a) That applicants hold or have held the T.C.R.G., A.D.C.R.G. or T.M.R.F. certificates since 1965 and were registered with the Coimisiun since 1965.
- b) That such applications are submitted individually and on the official application form
- c) That such application be received before 1st June 1971.
- d) That the appropriate registration fee accompany the application
- e) That each applicant agrees to abide by the rules, ruling and Constitution of An Coimisiun.

As a gesture of goodwill An Coimisiun is prepared to double the Teacher/Adjudicator representation on An Coimisiun from eight (8) to sixteen (16) and elected after June 1st 1971 by the general body of teachers and adjudicators registered at that time.

Registration with An Coimisiun would entitle:

1. All teachers to enter their pupils for all registered competitions and championships
2. All adjudicators to judge at all such competitions both at home and abroad.

Those registered would also now benefit by improved services provided by a part-time official and we hope at a later date to be in a position to employ a full time secretary.

We hope that all teachers and adjudicators will give earnest consideration to the above proposals and that soon we will all be under one organisation.

Le tamall anuas ta buairt ar an Choimisiun le Rinci Gaelacha i dtaobh an tionchuir ata ag aighneas i gcursai rince ar rince Gaelacha ar fuaid na tire.

Ta se curtha ar an suile freisin a bhfuil de dhea-thoil ar gach taobh le haghaidh reitheach an aighnis. Tri obair idirmheantoiri bhi ar chumas daoine aonraice on da thaobh bualadh le cheile agus ple a dheanamh ar slite agus modhanna chun teacht ar reiteach.

Pleadh o tosach deireadh moltai a d'eirigh as na cruinnithe seo le linn cruinniu den Choimisiuin ar 27 Feabhra 1971 agus measadh go mbeadh na socraithe seo leanas inghlactha ag gach muinteoir agus moltoir.

Ta an Coimisiun toilteanach gach muinteoir agus moltoir a chluar sna ranna cui ar an gcoinnioll

- a) Go bhfuil no go raibh teastais T.C.R.G., A.D.C.R.G. no T.M.R.F. o 1965 i leith agus claraithe o 1965. aige/aici
- b) Go ndeintear a leitheid de iarratais go haonaranach ar an bhfoirm iarratais oifigiuil
- c) Go mbionn a leitheid d'iarratais faighe roimh i Meitheamh 1971.
- d) Go mbionn an taille claruchain cui i dteannta an iarratais.
- e) Go ngeallann gach iarratosoir go gcláifidh se le rialacha an Choimisiuin

Mar chomhartha dea-mheine, ta an Coimisiun toilteanach an ionadaíocht Muinteoiri/Moltoiri ar an gCoimisiun a dhuhailt o ochtar (8) go seisear deag (16) ball le haghaidh bliain amhain. Beidh na hionadaithe seo ainmhithe agus tofa i ndiaidh Meitheamh 1971, ag na muinteoiri agus moltoiri claraithe ag an am.

Tri chluar leis an gCoimisiun bheadh teideal:

1. ag gach muinteoir a gcuid daltaí a chur isteach ar gach comortas agus craobh comortas claraithe.
2. ag gach moltoir moltoireacht a dheanamh ar gach comortas da leitheid sa bhaile is i gcein.

Bheadh buntaisti seirbhisi feabhsaithe a sholathar ag oifigeach pairt-aimsire faoi thuarastaíanois ar fail acu siud a bheadh claraithe, agus ta suil againn bheith in ann runai lan-aimsire a fhostu amach anseo.

Ta suil againn go dtabharfaidh gach muinteoir agus moltoir eisteacht doimhín do na moltai thuasluaite agus go mbeimid ar fad aontaithe in aon eagraíocht amhain sar i bhfad.
